Terms of Assignment

Your assignment will be governed by the terms and conditions of the Directorate of Land Records & Survey, Patna and following specific employment terms and conditions listed in this document. Please read the same carefully.

1. NATURE OF AGREEMENT

- i. You will be engaged on contractual basis in the Directorate from your Date of joining and you will be working as per your job requirements or as will be decided by the Directorate, from time to time.
- ii. This is a time bound engagement on contract and the personnel cannot and will not claim for any extension or even permanent employment. The personnel is not entitled to any benefits/ allowances other than those mentioned for the respective position as mentioned in the recruitment notification or will be decided by the Directorate, from time to time.

2. DUTIES & RESPONSIBILITIES

In view of your work, you must effectively and efficiently perform to deliver on the expected results. Your duties and responsibilities will be described at the time of training and may be modified, supplemented, amended or rescinded at any time during your engagement.

3. REMUNERATION

You will be paid remuneration as mentioned in the recruitment notification for the position against which your candidature has been accepted.

4. DOCUMENT VERIFICATION

- i. Your assignment is based on the information and documents submitted by you and will be subject to police verification report / criminal records and verification of applicable educational details and experience certificates produced during the counseling process.
- ii. If any declaration given or the documents furnished by you to the Directorate of Land Records & Survey proves to be false or if you are found to have willfully suppressed any material information at any point in time, in such case, you will be liable to removal from engagement summarily.
- iii. You will have to bring all documents mentioned in Joining Document Checklist.
- iv. Due to schedule of training for new selected candidates for training in Survey Training Institute, Shastrinagar, Patna, the joining date of selected candidates may be different but it will not effect their seniority.
